The 2018 Boston Open will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the current U.S. Figure Skating rulebook, as well as any pertinent updates which have been posted on the U.S. Figure Skating website. At the referee's discretion, group sizes may exceed the current maximums in rule 2466.

**ELIGIBILITY**: This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules, and who are a currently registered member of a U.S. Figure Skating member club, a collegiate club or an individual member in accordance with the current U.S. Figure Skating rulebook. Skaters representing a foreign association, must refer to the U.S. Figure Skating rulebook regarding entry rules.

# COMPETE USA ELIGIBILITY (EXCEL BEGINNER & EXCEL HIGH BEGINNER ONLY):

Excel Beginner and Excel High Beginner event registration is open to all members of either Learn to Skate USA or those who are full members of U.S. Figure Skating. Eligibility will be based on skill level as of closing date of entries. All Snowplow Sam and Basic 1-6 skaters must skate at highest level passed or one level higher and NO official U.S. Figure Skating tests may have been passed, including Moves in the Field or individual dances.

**TEST LEVEL**: Competition level is defined as the highest test passed as of the entry deadline in the discipline the skater is entering. Entrants may skate one level above that for which they qualify, but they may not skate down in any event. Skaters may enter either well balanced or the <u>excel program</u> (formally test track), but not both.

## **ENTRIES:**

Entries will only be accepted through online registration. Online registration using the U.S. Figure Skating EMS Portal via www.usfsaonline.org is the ONLY method available to enter the competition.

\*\*Only one team member for partnered events registers for the competition and purchases practice ice, please take that into account for entry/practice ice fees as it won't be split.

#### SKATE CANADA MEMBERS/FOREIGN SKATERS:

# **EMS SKATER PORTAL**

After registration is complete, skaters will have access to the EMS Skater Portal. The portal consists of music upload, PPC (IJS events), coach management, practice ice and competition schedule. If you need assistance with EMS, please email <a href="mailto:ProductSupport@usfigureskating.org">ProductSupport@usfigureskating.org</a>. \*Note: for partnered events, the team member who registered for the competition has access to EMS

**DEADLINE: DEADLINE: Friday, August 24, 2018**. Late entries will only be accepted at the discretion of the Chief Referee and Competition Chairs. Additionally, a late fee will be assessed.

**REFUND POLICY:** Entry fees will not be refunded after August 24, 2018 unless no competition exists or the event is cancelled. There must be two competitors to hold an event. There will be no refunds for medical withdrawals. The online processing fees are not refundable. Contested credit card charges will require an additional \$25 fee to complete the registration. Payment of all fees will be required before the skater is allowed to participate in practice ice or events.

**FACILITIES**: The competition will be held at The Skating Club of Boston at 1240 Soldiers Field Road, Boston, MA 02135. The ice surface measures 85 feet X 193 feet. The arena has locker rooms. Please refer to the Club's website, www.scboston.org, for directions to the facility, and for instructions on parking in the area.

**REGISTRATION:** On-site check-in will be open before the first event/practice and run through the last event of the day. Please register promptly upon arrival. Skaters are requested to **arrive two hours prior to the scheduled time of their event in case the competition is running early.** The first scheduled event of the day will begin ontime so two hours early is not necessary if you are entered in that event.

MUSIC UPLOAD: DEADLINE: Sunday, September 1, 2018 All competition music must be uploaded via the EMS Skater Portal as a MP3 file. If your music is not in MP3 format, please consider using the free applications – Format Factory (PC) or Audacity (Apple). Please note, U.S. Figure Skating/LOC does not endorse any conversion software. A late fee of \$10 will be assessed if music is not uploaded by the deadline.

**PRACTICE ICE:** Unofficial practice ice (UPI) is not included in your entry fee and can only be purchased through the EMS Skater Portal. Practice ice will be held at both The Skating Club of Boston and the Daly Rink. Practice ice at The Skating Club of Boston will be limited. Please refer to the competition website for additional information with regards to practice ice.

<u>VIDEOGRAPHY/PHOTOGRAPHY:</u> ProEventPhoto will provide these services. One complimentary video download will be included with each's skater's registration. All photography and recording are restricted to handheld battery operated equipment, without monopod or tripod. Photography or recording for any commercial purpose is strictly prohibited.

**AWARDS:** Awards will be given for 1st, 2nd, 3rd and 4th place finishes for all events.

**FEES**: All fees are payable in U.S. dollars.

- **First Event** = \$150 (for Pairs teams, this is the total cost per team.)
- **Each Additional Event = \$75** (for Pairs teams, this is the total cost per team.)

**OFFICIAL NOTICES:** An official competition bulletin board will be maintained at The Skating Club of Boston during the competition. It is the responsibility of each competitor, parent, and coach to check the bulletin board frequently for any schedule changes and/or additional information. A tentative schedule of events will also be posted at www.scboston.org prior to the start of the competition.

<u>SCHEDULE:</u> The competition schedule is subject to change at all times at the discretion of the Chief Referee. <u>Competitors must be ready to skate up to one hour prior to the scheduled event start time. This also includes the practice ice.</u>

**FINAL ROUNDS:** Final rounds will be held at the discretion of the Chief Referee and the Competition Organizing Committee.

**CRITIQUES:** Critiques will be offered for International Judging System (IJS) events Juvenile – Senior immediately upon the conclusion of the event. Location will be announced prior to the start of the competition.

**LIABILITY:** U.S. Figure Skating and The Skating Club of Boston accept no responsibility for injury or damage sustained by any participant in this competition. As a condition of and in consideration of the acceptance of their entries or participation therein, all entrants, their parents/guardians and officials shall be deemed to agree to assume all risks of injury to their person and property resulting from, caused by or connected with, the conduct and management of the competition, and to waive and release any and all claims which they may have against any officials, U.S. Figure Skating, or The Skating Club of Boston and against their Officers, and their entries shall be accepted only on such condition. This is in accordance with Rule 1600 of the official U.S. Figure Skating Rulebook.

## **INFORMATION REGARDING COACHES:**

U.S. Figure Skating Rule MR 5.11 Coach Compliance

COACHES – To be a credentialed coach at a sanctioned nonqualifying competition, coaches of U.S. Figure Skating members must meet the following requirements:

- Current member in good standing with U.S. Figure Skating
- Completed background check (green light status)
- Completed Safesport Training and Education The online program is FREE to U.S. Figure Skating Members via <a href="https://www.usfsaonline.org">www.usfsaonline.org</a> and is valid for two (2) years after the completion date
- Continuing Education Requirements (CERs) for the 2018-19 Competition Season

COACHES OF EXCEL BEGINNER & EXCEL HIGH BEGINNER LEVEL SKATERS (COMPETE USA):

- Learn to Skate USA Instructor membership OR U.S. Figure Skating full membership
- Completed Safesport Training and Education
- Completed background check (green light status) \*for coaches/instructors 18 years old and over
- Learn to Skate USA Instructor Certification \*for coaches under 18 years old

The Skating Club of Boston will have a list of compliant coaches who are approved to receive a credential at the competition. Coaches will need to check in at the event registration desk and show a government issued photo I.D. to receive a credential.

If a coach cannot provide a photo I.D. and is not on the list or cannot produce the necessary documents, he or she will not be allowed a credential. There can be <u>no exceptions</u> to this policy. The Skating Club of Boston strongly urges *all* coaches to have their U.S. Figure Skating cards with them. Non-credentialed coaches will not be permitted in the designated coaching area at rink side during events, including practice sessions. Coaching at a U.S. Figure Skating sanctioned event without compliance is an ethics violation, which the Club will be required to report to U.S. Figure Skating and the PSA.

**SAFESPORT:** We follow all SafeSport policies and guidelines of U.S. Figure Skating and USOC.

**6.0 EVENTS:** The 6.0 Majority Judging System will be used for the following events:

- A. No-Test and Pre-Preliminary
- B. Excel Program (formally test track): Beginner, High Beginner, Pre-Preliminary, Preliminary, Preliminary Plus, Pre-Juvenile, Pre-Juvenile Plus, Juvenile Plus, Intermediate, Novice, Junior, and Senior \*CLICK HERE FOR EXCEL PROGRAM REQUIREMENTS\*
- C. Adult Free Skating: Adult Pre-Bronze

**IJS EVENTS:** The International Judging System (IJS) will be used for the following events:

- A. IJS Singles Short Program and Free Skate (well balanced program): Preliminary (free skate only), Pre-Juvenile (free skate only), Juvenile (free skate only), Intermediate, Novice, Junior, and Senior
  - a. IJS Preliminary through Pre-Juvenile events will be called in according to the standard rules of IJS (see TN 201). Spins will be limited to a maximum of **level 1**.
- B. Adult IJS Free Skate (well balanced program): Masters Intermediate/Novice, Masters Junior/Senior, Adult Bronze, Adult Silver, and Adult Gold
- C. IJS Pairs Short Program and Free Skate (well balanced program): Pre-Juvenile (free skate only), Juvenile (free skate only), Intermediate (free skate only), Novice, Junior, and Senior

Per USFSA Rule: 4240

Juvenile Girls: Skaters entering free skate events (IJS well balanced program) <u>must be 12 years of age or younger</u> at the close of entries.

Juvenile Boys: Skaters entering free skate events (IJS well balanced program) <u>must be 13 years of age or</u> vounger at the close of entries.

Skaters entering Beginner through Pre-Juvenile events will be divided as closely as possible by age should the number of entries warrant more than one group.

<u>PLANNED PROGRAM CONTENT (IJS ONLY)</u> – <u>DEADLINE: Sunday, September 1, 2018</u> A late fee of \$10 will be assessed if PPC is not uploaded by the deadline.
