## 2019 Summer Guidelines for Contract Ice

June 23, 2019 – August 24, 2019

1. These guidelines apply to Club members and non-members who contract ice at either the Boston or Foxboro locations during the 2019 Summer Session. Please note that the deadlines provided below apply to those contracting at the Boston location.
2. Members of The Skating Club of Boston will have first priority.
  - A) **Club member skaters** will be assigned ice in the following order of priority:
    - 1) Club membership seniority (how long you have been a member);
    - 2) Highest US Figure Skating free skating test passed (**as of Monday, April 1<sup>st</sup>**);
    - 3) Date of application submission.
  - B) **Non-Club member skaters** will be assigned ice in the following order of priority:
    - 1) Highest US Figure Skating free skating test level passed (**as of Monday, April 1<sup>st</sup>**);
    - 2) Date of application submission.
3. Applications not submitted by the **Friday, May 3, 2019 priority deadline** will be processed as they arrive and *not* granted the above priorities. (**NOTE: Applications will not be processed for Club house accounts not current.**)
4. For those who are contracting sessions through ActiveNet, priority will be determined by the membership criteria previously provided and will be processed as they arrive.
5. Applications without acknowledgment to the terms of the Amateur Athletic Waiver and Release of Liability or For Participants of Minority Age forms will not be accepted.
6. Summer Ice charges will be reflected in the monthly account statement beginning in the May billing period. The balance for those who wish to contract is due in full by June 23, 2019 **or your contract will be voided.**
7. Pair teams must submit separate applications, **clearly marked as to which session(s) they are requesting for the purpose of skating pairs.**
8. Skaters will be notified in writing if the Club is unable to accommodate their requested assignments.
9. Please remember that:
  - No refunds will be made after the start of the summer session on June 23, 2019.
  - No cancellation of requested ice time can be made after the start of the summer session on June 23, 2019.
10. Management reserves the right to cancel any session or class that is under-subscribed, or to make changes to the schedule, if necessary.

## Amateur Athletic Waiver and Release of Liability

In consideration of being allowed to participate in any skating or related activities at The Skating Club of Boston or elsewhere sponsored by The Skating Club of Boston, the undersigned acknowledges, appreciates, and agrees that:

2. **I knowingly and freely assume all such risks**, both known and unknown, **even if arising from the negligence of the releases** or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary terms and conditions for participation. If however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, **hereby release and hold harmless The Skating Club of Boston**, its officers, officials, agents and/or employees, other participants, sponsors, advertisers, and, if applicable, owners or property, **whether arising from the negligence of the releases or otherwise.**

**I have read this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.**
